Book Review - Douglas R. Handy, CSP

Within the last month I have taken the opportunity to read books by 2 different authors, both of which I receive weekly email and information from. Both of these authors are people that I respect for the knowledge in their fields and for their commitment and perseverance in their quests in life. Their fields are different, yet for me as a Safety Professional, I have found them to be great resources of thinking in a different way, which has in turn helped me greatly in my personal and professional efforts. Interestingly is that both of these books are about the habits and traits of Sharks. These authors are Jon Gordon (book is The Shark and the Goldfish) and Walter Bond (the book is SWIM!) I would recommend both of these books to you.


The Shark and Goldfish: Positive Way to Thrive During Waves of Change – is a fun and easy reading book. Tells the story of a Goldfish that ends up in the Ocean and has a Shark for a Mentor. Changes are needed for the Goldfish to survive, with the first and most important change is how to think and change your perspective when great changes occur.

We have been able to experience some great changes in our lives and our profession in 2020, and the wave of changes is likely to only continue as we go forward. How we do business, interact with people and even run our daily lives has and will continually change. This story of some new rules, perspectives and ways of life for the little Goldfish as taught to him by the Shark are essential for survival. As changes take place the goldfish and other suckerfish can also be of great benefit to the mighty Shark.

The overall story and question of the book are: "What do you want to be? Every day, you have a choice of whether you are going to be a shark or a goldfish. You have a choice of whether you are going to wait to be fed or whether you are going to find food. Each day, you make this choice with your thoughts, beliefs, and actions the choice is yours."

Some great tips on change and staying positive – the real focus of Jon Gordons's books, are given with some good examples – at least good examples for a Goldfish. These can be easily translated to people's lives and the lives of a Safety Professional.

SWIM! - the second book is by Walter Bond also is about Sharks, their traits, strengths and why they are so dominant. This book is a story of 2 successful business owners who reunite many years after High School and go on a fishing trip. One of each of their children go along and are part of the adventure.



This book I found to be a thought-provoking book on how to work with and inspire people to be their best in business and in day to day life. There are many good thoughts and lessons intertwined within the story and good wisdom is shared between the travelers. As is true so many times in real life, the most successful and wisest businessman is also the least boastful.

Some great keys are in the book – all related to traits and habits of sharks. "The Sacred 6" about Sharks are revealed and discussed by all the travelers, with real time stories to assist in the understanding of each principle. "The Sacred 6" are (1) Sharks never stop moving forward. (2) Sharks never look down, they always look up. (3) Sharks are always curious and always learning.

I guess you will have to read the book to get the last 3 of "The Sacred 6". The six rules/principles are ones that I have heard in the past, yet by putting them all together there is some wisdom and provide one overall plan/method for success.

Both of these books are useful tools in our profession and in our lives, as they can assist us in thinking differently, adapting to changes and can give a direction as we change and improve our lives.

UOSH Advisory Meeting Report

UOSH recently held their third quarter, 2020 fiscal year, Advisory Council meeting virtually for the first time. Cameron Ruppe, UOSH Director, reviewed Utah workplace fatality data, accident reporting numbers and UOSH inspection data through the 2020 fiscal year. Mr. Ruppe stressed that there has been a recent upturn in workplace fatalities in the state of Utah which he partially attributes to the focus on Covid-19 illness prevention. The theory is that this may remove some focus from more traditional risks like falls and struck-by accident prevention.

In addition to talking about Covid-19 and the current state requirements, Mr. Ruppe stated that there have been some Covid-19 related workplace complaints and UOSH has started to do some Covid-19 related compliance inspections. He also reviewed recent legislation regarding Covid-19 including HB5006 which substantiates workers' compensation coverage for Covid-19 illness in certain professions. The council also discussed SB3007 a bill which would prevent people from suing businesses for contracting Covid-19. Lastly, Mr. Ruppe went over Covid-19 resources available through UOSH and the Labor Commission.

Finally, the UOSH Director discussed the Local Emphasis Programs (LEP's) including a new one on Silica to comply with federal OSHA's inspection requirements for this new rule. Starting on August 4, 2020, UOSH will have 2% of overall inspections dedicated towards looking at Silica rule compliance. He reiterated that these compliance inspections could be wrapped into other inspections but that at least 2% of inspections will focus on this rule in some aspect. After public comment, Mr. Ruppe announced the next meeting of the Advisory Council will be held in October.
