#### **ASP-CSP Study Question of the Month**

ABC Transportation facility has two 1,000 gallon above-ground storage tanks (AST). One has about 500 gallons of diesel. The other is nearly empty, containing only a few gallons of gasoline. In a recent inspection of their fuel storage, the inspector cited them for not having an SPCC plan. The EHS manager complained, stating that they never have more than 600 gallons of diesel at any time, and the gasoline tank is no longer in use. Did the citation stand?

- A. Yes, because the inspector has a lot of leeway when interpreting the rules.
- B. Yes, because the requirement for an SPCC plan is based on capacity.
- C. No, because the amount on hand at any one time is less than 1,320 gallons.
- D. No, because fuel is exempt from the rule.

#### **Technical Article**

Traffic Crashes in Utah in 2021

In 2021, Utah roads had more than 61,000 crashes out of which 0.48% of crashes resulted in fatalities. To put it bluntly, Utah roads faced 329 fatalities and 1732 serious injuries alone in 2021. If we dig deeper, 21 of these fatalities were the result of aggressive driving, 10 were the result of drowsy driving, 12 were the result of distracted driving, 147 were DUI involved, and 93 were speed related. These numbers are fact, and these do sound depressing but what have each of us done to curb this effect?

Crash frequency and severity are common measures of roadway safety.

Crash severity is based on this scale.

**KABCO** 

K- Fatal

**A**-Suspected serious injury

**B-** Suspected minor injury

**C**-Possible injury

**O-** no injury (property damage only)

#### **ASP-CSP Study Question -Solution**

The Spill Prevention Control and Countermeasures rule applies to facilities with an aboveground oil storage capacity of 1,320 U.S. gallons or more in 55 gallons or greater containers. ABC Transportation can either develop and implement an SPCC plan or downsize its storage capacity to comply with the rule. It is important to note that other factors may cause the need for an SPCC plan, including used oil containers and oil used as a coolant inside transformers. The correct solution is B.
